

# China hybrid inverter on grid in Belgium



## Overview

The EU has taken its most direct step yet to cut Chinese clean energy hardware out of publicly funded projects, banning Chinese inverters from all EU-funded schemes in a move Brussels described as the first in a series of actions targeting high-risk suppliers. The global manufacturing landscape for hybrid solar inverters (HS Code 8504. 40) is undergoing a structural realignment. While China remains the dominant production hub, accounting for a significant portion of global output, manufacturers are increasingly diversifying their footprint to mitigate. The European Commission will gradually eliminate the use of Chinese-made inverters in EU-funded energy projects, a major step aimed at protecting critical energy infrastructure from possible cyber threats that could trigger power outages. Now, manufacturers must rely on European alternatives, which risks increasing European energy bills and production costs. “We decided we will take concrete.
