Prevent backfeed – Only have a licensed electrician wire a building's electrical system into a. When ever possible, face the generator air inlet openings away from the wind. The wind can prevent the air intake louver from opening on start up. The air inlet must be capable of moving enough air through the room to provide the correct minimum CFM (cubic feet per minute) cooling for generator as. Minimum clearance requirements: NFPA 110 recommends a minimum of three feet at the front and sides of the generator for access, while NFPA 37 calls for five feet for clearance from the opening, combustibile walls, and for general access. Windows and.
