Overview

In 2014, Georgetown reduced our carbon footprint by over 71% through a combination of energy efficiency in our facilities and procurement of renewable energy certificates (RECs) for 100% of our power, meeting our GHG goal six years ahead of target. But our work doesn't stop there. Since reaching our goal to cut the university's greenhouse gas emission in half.
