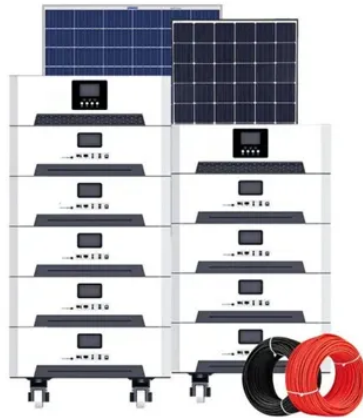

Section 25D of the Internal Revenue Code provided a 30% nonrefundable tax credit for residential solar photovoltaic systems, battery storage, and geothermal heat pumps. It was scheduled to run through 2034.
