In 2022, more than 320 new patent applicants entered the solid-state Li-ion battery-related patent landscape, with three-quarters filing only one patent family (i.e., unique inve. Several non-Chinese startups incorporated after 2016 entered the solid-state Li-ion battery patent landscape in 2022, mainly originating from South Korea and the U.S. Even though most Japanese companies had started filing patents on solid-state batteries many years earlier, some of them only joined the IP landscape in 2022, such as material manu.
