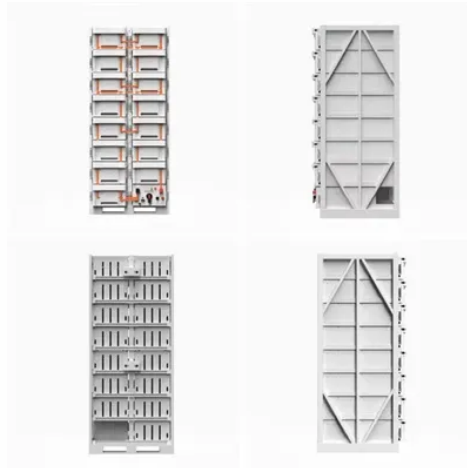


Safe distance for solar energy storage



Overview

For safety purposes, the distance between the ESS and residential buildings must be no less than 12 m, and the distance between the ESS and densely populated buildings such as schools and hospitals must be greater than 30. If a firewall is installed, the short side distance can be reduced to 0. • Per T/CEC 373-2020, battery containers should be arranged in a single-layer configuration.
